

# MEMBERSHIP REQUIREMENTS

## QUALIFICATIONS

Individuals or companies who are actively involved in service contracting in the public and private sectors.

## INDIVIDUAL MEMBERSHIP

Any eligible individual who pays an annual membership fee as prescribed by the Board of Directors shall be entitled to all of the rights and privileges of the Association. Individual members are entitled to full voting rights, and may be officers of the Association.

## CORPORATE MEMBERSHIP

Any corporation and any employees of that corporation who pay the stated membership fee may be a Corporate Member of the Association. Corporate members may assume all the rights and privileges of the Association including the right to vote and hold office. Corporate membership shall only be entitled to cast a maximum of three votes on any matter to be voted on by the membership. If two or less individuals represent the corporation, they shall have only one vote each.
