Legislative Matters Pat O'Donnell Terrence Murphy Damien Walsh	Paul: -Regarding SAM.gov – If you had a proposal due yesterday make sure to call your Contracting Officer and let them know. Pat: -Three decisions: 1) GAO decision – 8a set aside and 9a joint venture mentor submitted past performance from 9a and won the award. The protestor said that the past performance rating of satisfactory was unreasonable because SBA regulations imply that they must evaluate the 8a companies past performance. GAO overturned and said in that instance simply providing past performance for the 9a only violated SBA regulations. 2) Federal Claims – Two former joint ventures went their separate ways and were competing for the follow-on work. The managing former joint venture was awarded the follow-on work and as the managing former joint venture only did 10% of the work. The protestor said that not only is the rating of satisfactory past performance unreasonable, but they essentially deceived the procuring agency by not disclosing that they claimed past performance work that they did almost nothing. The

interesting about this case is the Court of Federal Claims took testimony to augment the record, which is unheard of. The lesson here is that if you get in front of the Court of Federal Claims and there is an allegation that you have deceived by the way you have characterized your past performance, then you should not be surprised that the Court allows the protestor to put people under oath and start exploring that issue and that could result in all sorts of collateral problems.

3) Federal Claims – Both members of the joint venture were registered in SAM separately. The solicitation said the offeror has to be registered in SAM both at the time it submits and at the time of award. But the joint venture itself was not registered. It was protested and the Court of Federal Claims said it was quite clear from the solicitation what you had to do, and you did not do it. It does not matter that you both were registered individually, the joint venture was not registered, so the award was taken away on a technicality.

There is more of an attempt to provide information ahead of the solicitation and answer questions one-on-one from potential offerors. I think that's a good thing. There is less one-on-one personal contact between industry and government, and it appears the solution is to have industry days to get everyone online and answer questions. It's another way to get information out. I suggest you stay tuned to SAM.gov and try to highlight those specific agencies that you're interested in because more of these

	industry days are cropping up to try to push more information out.
