	see a new error message as catalog data migrates to the new
	Authoritative Catalog Repository (ACR). The message will
	say "Special Item Number [SIN] is Unauthorized for
	Contract." This will occur even if no products are listed
	under the SIN.
	You will receive this error message when you submit a
	catalog transaction that contains SINs not awarded to the
	contract. Please note that all SINs listed at the contract and
	product level must be awarded to the contract, or the
	transaction will be rejected. If the contract was recently
	awarded the SINs, wait one (1) day then resubmit the
	catalog.
	If a contractor receives this error, they should

- remove the unawarded SIN and resubmit the catalog transaction.
- Contractors can check <u>GSA eLibrary</u> to verify which SINs are awarded to their contract.
- Contractors can add SINs to their catalogs by first submitting an Add SIN modification via eMod.

The ACR is a part of GSA's overall effort to improve our catalog management infrastructure. The ACR processes catalogs submitted via the FAS Catalog Platform (FCP), the Schedule Input Program (SIP), and EDI-832. The ACR significantly decreases processing time as compared to legacy databases, resulting in contractors getting error reports faster, the workforce receiving catalogs for review faster, and GSA Advantage! publishing updates faster. The ACR also ensures GSA can enforce business rules and requirements to ensure customers have access to high quality, accurate information on GSA Advantage!

- SBA DSBS must now be updated via connect.sba.gov. You use your Login.gov information (email and password), then select Access, then select DSBS add your UEI and bank account number associated with your SAM profile to be approved to update DSBS profile.
- -SAM issues: There seems to be two new clauses in the reps & certs, DFARS 252.226-7002 and DFARS 252.232-7015. 252.226-7002 Representation for Demonstration Project for Contractors Employing Persons with Disabilities. As prescribed in 226.7203, use the following provision: REPRESENTATION FOR DEMONSTRATION PROJECT FOR CONTRACTORS EMPLOYING PERSONS WITH DISABILITIES (DEC 2019)
- (a) Definitions. As used in this provision—
 "Eligible contractor" means a business entity operated on a for-profit or nonprofit basis that—
- (1) Employs severely disabled individuals at a rate that averages not less than 33 percent of its total workforce over the 12-month period prior to issuance of the solicitation;
- (2) Pays not less than the minimum wage prescribed pursuant to 29 U.S.C. 206 to the employees who are severely disabled individuals; and

(3) Provides, for its employees, health insurance and a retirement plan comparable to those provided for employees by business entities of similar size in its industrial sector or geographic region.

"Severely disabled individual" means an individual with a disability (as defined in 42 U.S.C. 12102) who has a severe physical or mental impairment that seriously limits one or more functional capacities.

- (b) Demonstration Project. This solicitation is issued pursuant to the Demonstration Project for Contractors Employing Persons with Disabilities. The purpose of the Demonstration Project is to provide defense contracting opportunities for entities that employ severely disabled individuals. To be eligible for award, an offeror must be an eligible contractor as defined in paragraph (a) of this provision.
- (c) Representation. The offeror represents that it [] is [] is not an eligible contractor as defined in paragraph (a) of this provision.

252.232-7015 Performance-Based Payments-Representation. As prescribed in 232.1005-70 (b), use the following provision: PERFORMANCE-BASED PAYMENTS—REPRESENTATION (DEC 2022)

- (a) In accordance with 10 U.S.C. 3802(c), the Contractor's financial statements shall be in compliance with Generally Accepted Accounting Principles in order to receive performance-based payments.
- (b) The Offeror represents that its financial statements are [] are not [] in compliance with Generally Accepted Accounting Principles.

(End of provision)

Paul:

-WOSB certification – There is confusion about being SWAM certified as WOSB and SBA certified WOSB. Virginia APEX Accelerator (PTAC) can help them get you get your cert at no charge.

-Additional note – DCAA does not "certify" your accounting system. Be on the look out for spam email.

Legislative Matters Pat O'Donnell

Pat:

-If your contract is relying on another company's past performance, make sure you are disclosing the details in the proposal. A company who brought on employees who performed work on a previous contract submitted a proposal, but disclosed the details was properly awarded a new contract due to the information being spelled out.

-A proposal was rejected due to not cross referencing past performance to the statement of work in their proposal in the area requested by the government.

Paul Staley:

-This happens quite frequently, contractors need to take the extra time to review and have good review teams.

Paul Hawkins:

-Pentagon issues rule to ban TikTok on all DODconnected devices, including for contractors Contractors are mandated to update their internal workplace technology policies to incorporate the new requirements.

"In February, following the passage of the No TikTok on Government Devices Act late last year, the Biden administration issued guidance to federal agencies mandating that they ensure TikTok was no longer accessed on federal hardware in the following 30 days. The new interim rule issued by the Defense Department, along with the General Services Administration, and NASA, on Friday takes that a step further to impose it on contractors as well, implementing the statute within any contract solicitations that those agencies release from June 2 onward. Any solicitations issued before, but awarded after June 2 have to be reissued and amended to comply with this interim rule by July 3.

"This prohibition applies to devices regardless of whether the device is owned by the government, the contractor, or the contractor's employees (e.g., employee-owned devices that are used as part of an employer bring your own device (BYOD) program)," officials wrote in a <u>summary of the new rule</u> published on the Federal Register.rule by July 3."
